NARRATIVE

FORCED ENTRY WAS USED TO OPEN THE DOOR AND THE VICTIM (ABRAHAM K. BIGGS JR) WAS FOUND DECEASED ON HIS BED. THE VICTIM WAS LYING ON HIS LEFT SIDE FACING EAST AND IT APPEARED THAT HE HAD VOMITED. THE VICTIM ALSO HAD FOAM DISCHARGE AROUND HIS MOUTH AND NOSE. THE VICTIM WAS COLD TO THE TOUCH AND RIGOR MORTIS HAD BEGUN TO SET IN. THE VICTIM WAS WEARING A GREENISH COLORED SHIRT, AND WHITE BASKETBALL STYLE SHORTS, AND A BLACK HAT. I LOCATED A DETAILED SUICIDE NOTE ON TOP OF THE COMPUTER KEYBOARD. (IT SHOULD BE NOTED THAT BOTH COMPUTER SCREENS WERE ON AND A WEB CAM WAS FACING THE BED AND IT APPEARED THAT HE MAY HAVE BROADCAST HIS DEATH ON THE INTERNET.) ON ONE COMPUTER SCREEN WERE INSTANT MESSAGES TO AN U/K PERSON STATING THAT HE HAD TAKEN 8 XANAX PILLS (16 MG) AND "ROOFIES" AND AN U/K AMOUNT OF LEXAPRO. ON THE OTHER SCREEN WAS LIVE CHAT WITH U/K PERSONS DISCUSSING THE SITUATION THAT HAD JUST OCCURRED IN THE DECEASED'S BEDROOM. ALSO FOUND IN THE ROOM WAS AN EMPTY PILL BOTTLE PRESCRIBED TO THE DECEASED, THE PRESCRIPTION WAS FOR LEXAPRO. THE BOTTLE WAS OPEN ON THE WINDOW SILL AND THE CAP WAS LYING NEXT TO THE KEYBOARD WITH A FEW PILLS INSIDE OF THE TOP. IN ADDITION THERE WERE OPEN ALCOHOL BOTTLES AND A PACKAGE OF BLACK AND MILDS IN THE BEDROOM NEAR THE BODY.

A CONTINUED SEARCH OF THE RESIDENCE REVEALED THAT THE REAR BEDROOM DOOR WAS ALSO LOCKED. FORCED ENTRY WAS MADE INTO THAT ROOM; HOWEVER IT WAS CLEAR AND IT WAS DETERMINED THAT NO ONE ELSE WAS INSIDE THE RESIDENCE.

A CRIME SCENE LOG WAS STARTED AND SGT COVINO WAS NOTIFIED.

THE VICTIM'S FATHER (ABRAHAM BIGGS SR) ARRIVED HOME AND ADVISED THAT HE LAST SPOKE TO HIS SON IN THEIR HOME OFFICE BETWEEN 0400 AND 0500 HRS TODAY.

THE VICTIM'S MOTHER (DOREEN BIGGS) ARRIVED AND ADVISED A LONG HISTORY OF HER SON'S DEPRESSION. THE MOTHER (AN R.N.) ADVISED THAT HER SON HAD BEEN BAKER ACTED IN AUGUST OF 2007 BY HER AND ON SEPTEMBER FIRST OF THIS YEAR. THE MOTHER STATED THAT ON 09/01/08 HER SON HAD ATTEMPTED SUICIDE BY TAKING A LARGE AMOUNT OF XANAX AND THAT HE HAD BROADCASTED HIS ATTEMPT ON THE INTERNET AND THAT HIS ATTEMPT HAD BEEN INTERCEPTED AND HE WAS TRANSPORTED AND HELD FOR 72 HOURS. THE MOTHER ALSO ADVISED ME THAT HER SON SUFFERED FROM ASTHMA AND ONCE BOUGHT A LARGE AMOUNT OF CIGARETTES HOPING THAT IF HE SMOKED THEM ALL IT WOULD SUFFOCATE HIM AND HE WOULD DIE.

THE MOTHER SHOWED ME A TEXT THAT SHE RECEIVED FROM HER SON ON TODAY'S DATE AT 0418. THE TEXT READ AS FOLLOWS, "IT'S NOT EVEN LIFE IS BORING, I ACTUALLY LOATH MY LIFE AND IT'S PRETTY MUCH BETTER THAN A LOT OF OTHER." MS. BIGGS STATED THAT SHE IMMEDIATELY CALLED HER SON AND HE INSISTED THAT HE WAS NEITHER DEPRESSED NOR SUICIDAL AND THAT HE PLANNED ON GOING TO WORK WITH HIS FATHER ON TODAY'S DATE.

DET. A. SCHORB AND DET. J. RYAN RESPONDED TO THE SCENE.  
IN ADDITION DET. S. WETTERER RESPONDED IN REF. TO THE COMPUTERS ALONG WITH C.S.T. M. BOONE FOR PROCESSING.  
ALSO THERESE SULLIVAN AND CEIL ALBERT RESPONDED TO ASSIST THE FAMILY

AT 1750 HRS ON 11-19-08 THE UNDERSIGNED RESPONDED TO \_\_\_\_\_, AT THE REQUEST OF DET SCHORB. PHOTOGRAPHS WERE TAKEN OF THE RESIDENCE AND THE DECEASED (BIGGS JR, ABRAHAM 12-23-88). PHOTOGRAPHS OF THE RESIDENCE INCLUDED DAMAGE TO DOOR LOCKS OF THE FRONT DOOR, NORTHEAST BEDROOM DOOR, AND SOUTH BEDROOM DOOR. THE DECEASED WAS LOCATED IN THE NORTHEAST BEDROOM ON HIS BED. THE DECEASED WAS WEARING A HAT, T-SHIRT, AND PAIR OF SHORTS. THE DECEASED'S HEAD WAS TO THE NORTH AND FEET TO THE SOUTH. THE DECEASED WAS COOL TO THE TOUCH WITH RIGOR MORTIS SET IN. FOAM WAS EXITING HIS MOUTH, THERE WERE NO OTHER VISIBLE SIGNS OF TRAUMA. A COMPUTER NOTE (ITEM #2 &3) WERE LOCATED ON THE COMPUTER KEYBOARD AND ALSO ON THE BEDROOM FLOOR. AN OPEN PRESCRIPTION BOTTLE OF LEXAPRO (ITEM #1) WAS LOCATED ON THE WINDOW SILL AND 7 TABLETS WERE ON THE COMPUTER KEYBOARD AREA. PHOTOGRAPHS WERE TAKEN OF CHAT ROOM TYPING AND PROGRAMS ON THE COMPUTER.

This Detective was called to a suicide scene ( \_\_\_\_\_ ) by Detective J. Ryan at 1627 hours. Upon arrival I observed a desktop computer with 2 screens in the victim's room. The computer was on-line. The website www.justin.tv <http://www.justin.tv> website was on the left screen and the forum "Bodybuilding.com on the right screen.

The Website www.justin.com <http://www.justin.com> was in a live chat room logged in and moderated by the screen name "feels\_like\_ecstasy".

The forum page ("ask a guy who is gonna OD(again) tonight anything") showed an document posted at 0156 hours by screen name "CandyJunkie" the document was an apparent suicide note.

NARRATIVE

\*This detective took screen shoots the forum letter and the chats from 0505hrs to 1813hrs. The screen shoots were copied onto Microsoft word and save on the department issued "Jetflash" memory stick.

A digital copy of the suicide letter was found on the desktop in Microsoft Word format. The letter was copied on the same memory stick.

The contents of the memory stick were transferred to the desktop in the computer lab office at headquarters. The documents were printed out and placed into property as evidence.

THE UNDERSIGNED RESPONDED TO THE SCENE WITH DETECTIVE RYAN PER CALL-OUT REQUEST OF SGT. COVINO. UPON ARRIVAL CONTACT WAS MADE WITH OFFICER V. HINES WHO ADVISED THAT A 911 CALL CAME VIA BSO IN REFERENCE TO A POSSIBLE IN PROGRESS SUICIDE. HINES ADVISED THAT OFFICERS MADE FORCED ENTRY INTO THE RESIDENCE, AND FOUND THE VICTIM'S BEDROOM LOCKED ALSO. OFFICERS THEN MADE FORCED ENTRY INTO THE BEDROOM AND LOCATED THE DECEASED VICTIM. HINES ADVISED THE CALLER STATED THE SUICIDE WAS BEING STREAMED LIVE ON A WEBCAM, VIA AN INTERNET CHATROOM BLOG. HINES ADVISED THEY DISCONNECTED THE CAMERA FOR THE WEBCAM, BUT WERE UNSURE HOW TO DISCONNECT THE AUDIO. THE CHATROOM BLOG WAS STILL ONGOING, WITH INDIVIDUALS IN THE CHATROOM WERE STILL COMMENTING ON THE POSSIBLE SUICIDE. THE UNDERSIGNED CALLED DET. WETTERER TO RESPOND AND DISABLE THE RECORDING EQUIPMENT AND TO CAPTURE THE CHAT ROOM BLOG. CRIME SCENE TECH BOONE RESPONDED AND PHOTOGRAPHED THE SCENE PRIOR TO IT BEING DUSTURBED.

THE UNDERSIGNED OBSERVED A "SUICIDE NOTE" LYING ACROSS THE KEYBOARD OF THE VICTIM'S COMPUTER. SEVERAL PRINTED COPIES OF THE SAME NOT WERE LYING ON THE FLOOR. A MAPQUEST WITH DIRECTIONS TO A RESIDENCE WERE LYING ON THE BED NEXT TO THE VICTIM'S LEG. THE UNDERSIGNED OBSERVED THE BODY AND FOUND NO INJURIES OF SIGNS OF FOUL PLAY. THE VICTIM HAD FROTH COMING FROM HIS NOSE AND MOUTH AND HAD REGURGITATED ON THE BED. THE UNDERSIGNED OBSERVED A BOTTLE OF LEXAPRO PRESCRIBED FOR THE VICTIM ON THE WINDOW LEDGE, AND A FEW OF THE SAME PILLS WERE LYING ON THE COMPUTER DESK. THE UNDERSIGNED READ THE SUICIDE NOTE, WHICH WAS TAKEN BY BOONE, TO BE PLACED INTO PROPERTY. THE NOTE STATED THAT THE VICTIM DID NOT WANT TO LIVE ANY MORE AND WAS INTENTIONALLY TAKING TOO MANY PILLS TO END HIS LIFE. THE WEBSITE CHAT ROOM STATED THE SAME INFORMATION. THE VICTIM'S CELLULAR PHONE WAS ALSO UNDER HIS BODY, AND HE STATED IN TEXT MESSAGES TO HIS FRIEND THAT HE WAS KILLING HIMSELF BY OVERDOSING ON PILLS.
